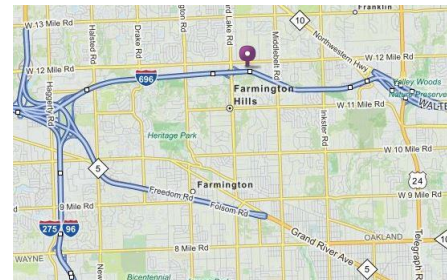
groups that represent approximately 9,000 individual investors. Program attendees can have the confidence that ARI's program content is vetted and solid.
